

ABOUT IAGA

riginally established as the National Association of Gaming Attorneys (NAGA), IAGA was founded in 1980 Nevada by several notable gaming attorneys including A.J. "Bud" Hicks, Frank Schreck, Robert Faiss, Frank Fahrenkopf and Mike Sloan. The organization's goal was to create a professional association of gaming industry attorneys "to unite in common organization those professionally engaged in the gaming industry, to facilitate negotiations in the gaming industry and protect and promote the mutual interests of the corporation's members and to promote and encourage education in the gaming industry."

The association soon drew the attention of gaming attorneys beyond Nevada who likewise wanted to support a forum where industry legal issues could be addressed, and NAGA's membership quickly grew to include attorneys not only from the United States but also from the United Kingdom, France and other international areas where gaming was legally regulated. As a result, and to recognize the organization's growing international membership, in 1985 NAGA evolved into the International Association of Gaming Attorneys (IAGA) and held its first international conference in Monte Carlo.

As the organization's annual conferences expanded beyond Europe to Australia, Canada and the Caribbean reflecting the globalization of the gaming industry and the increased international representation of its membership, the issues and strategies considered by IAGA began to require more than just legal expertise. As such, the organization's educational and networking events actively began including professionals from the gaming industry's financial and operational segments. And, to better reflect the expanded focus of the topics being addressed, in 2007 IAGA's name was changed to the International Association of Gaming Advisors, and its membership has since expanded to include not just gaming attorneys, but a wide range of industry financial experts, casino executives, regulators, consultants and educators from around the world.

Together, the industry experts that make up IAGA today meet throughout the year to discuss the key issues affecting global gaming. The organization and its members also actively participate in a wide range of activities focused on expanding the expertise and professionalism of the gaming industry, and encourage ongoing collaboration between the industry's legal, finance, operational, educational and regulatory advisors. As such, our members are regularly engaged in shaping the future of the industry and, through our conferences and collaborative opportunities, all members gain access to the collective heartbeat of the business.

LIFETIME ACHIEVEMENT AWARD

enny Williams, Commissioner and Chief Executive of the United Kingdom Gambling Commission, has had a distinguished civil service career that spans not just the UK gaming industry but includes roles related to rail and water regulation and privatization, local government finance, public sector housing management, business tax and tackling urban deprivation. As recipient of the 2015 IAGA Lifetime Achievement award, we recognize her significant contributions to the United Kingdom's gambling industry and in particular her leadership in guiding the country through an unprecedented period of growth and modernization.

Previously a Director General at the Lord Chancellor's Department, Ms. Williams joined the Gaming Board of Great Britain in 2004 to establish the Gambling Commission under the 2005 Gambling Act and develop all the licensing processes and associated

responsibility for all betting, gaming machine arcades and for remote gambling, growing to include over 250 staff and oversight of approximately 3,000 licensees while gaining prosecution and more extensive regulatory powers. The Commission's remit further expanded in 2014 when the National Lottery Commission merged into the Gambling Commission and again in 2014 when the 2005 Gambling Act was revised to require all overseas operators selling or advertising gambling to those in Britain to hold a Commission licence. Under her guidance, the Commission now regulates virtually all commercial gambling and lotteries in Great Britain. Ms. Williams is also a Trustee of the International Association of Gaming Regulators (IAGR) and Chair of its eGaming working party.

Ms. Williams has a Cambridge economics degree, worked in Zambia as an economist, and did postgraduate studies at Nuffield College, Oxford. The Vice Chair of homelessness charity the Connection at St. Martins, she and her husband have three grown sons.

The LIFETIME ACHIEVEMENT AWARD

was created to recognize individuals who have made an exceptional contribution to the world of gaming. The award is not limited by jurisdiction, sector or profession, nor is it restricted to members of IAGA. Additionally, it is not automatically awarded each year; the special nature of this award and the honor attached to it is preserved by awarding it only in years when IAGA identifies an individual who has made the appropriate contribution which is recognized internationally.







Regulating Automated Raffles

The sale of raffle tickets at sporting events and fundraisers is increasingly moving from the use of traditional paper tickets to sophisticated electronic sales channels. Using wireless handheld devices and kiosks for ticket printing, connected to back-office servers for storing and analyzing data, these systems provide real-time information to customers about pool sizes while allowing draw organizers more control over sales processes. Automation of these systems has enabled single event prize in six figures, thus changing the risk profile for this delivery channel. This session focuses on the unique features of electronic raffle systems and how the risks of their operation can be effectively mitigated through proven testing and auditing practices.

Anti-Money Laundering: Development Ideal Policies & Compliance Programs

Casinos stand at the forefront of regulator efforts targeting illicit proceeds that may enter the financial system. As customers find complex ways to channel funds both to and from casinos, the need for robust AML compliance programs continues to rise. While most gaming operators have installed the basic framework for their AML compliance program, new risks can arise when new services or technology are introduced or as markets change. DIANA BENNETT Chairman of the Board, Paragon Gaming

As Chairman of the Board and co-founder of Paragon Gaming, a developer and operator of gaming based properties, Diana Bennett is a secondgeneration casino operator and one of the most effective and respected executives in the gaming industry today. 
